1. Government Agency Contact Details

1.1. Emergency Call to Emergency Services - Fire and Rescue, Police, Ambulance - 000*

*The Duty Emergency Services Officer shall follow the site Emergency Response Plan - Emergency Plans when making decisions regarding the contacting of Emergency Services.

Any *Pollution Incident* should be reported immediately by the person nominated by GM or IC as required by the POEO Act once it has been determined that there is a risk of 'material harm to the environment'. It is the responsibility of the person nominated by GM or IC to activate the Pollution Incident Response Management Plan and notify agencies accordingly.

The notification shall include:

- All information relating to the incident such as; time, date, weather and duration of the incident.
- A description of the cause of the incident
- Identification of substances estimation of amount the amount of substance
- Any effect or harm to the environment as a result of the incident. Any harmful substances being released into drains
- Measures taken to minimise or mitigate the effect and prevent a recurrence.

2. Notification of adjoining agencies and land owners

2.1. In the event of a pollution incident where it is considered there maybe impacts to the health and wellbeing of adjoining landowners & agencies or environmental impacts to their land, as well as precautionary actions to be taken during and after the incident. The person nominated by GM or IC shall notify and update adjoining land owners by various methods such as telephone, door knocks, letters, website and radio.
